## DISCLAIMERS

**Tax Deductibility Notice.** Dues payments, contributions or gifts to the Ohio State Bar Association (Ohio Bar) are not tax deductible as charitable contributions for income purposes. However, they may be deductible as ordinary and necessary business expenses subject to restrictions imposed as a result of Ohio Bar lobbying activities. The Ohio Bar estimates that the deductible portion of your 2025 dues is 91%.

**Tax Deductibility on Friend of the OSBF Donations.** The Ohio State Bar Foundation (OSBF) is a qualified charitable organization under 501(c)(3) of the Internal Revenue Code. As such, your donation to become a Friend of the OSBF is 100% tax deductible.

**Ohio LAW PAC (Political Action Committee).** Contributions are discretionary and in addition to your dues. By law, only contributions from individuals, partnerships, LPAs, LLCs and LLPs should be remitted. Corporations, not-for-profit corporations and labor unions may not make contributions to political action committees. Members of such entities may contribute on their own. Contributions to LAW PAC are not deductible for a federal income tax purpose.

**CLE Discounts and Passes.** The 30% CLE discount for members enrolled in the basic membership plan is based off nonmember CLE prices. Certain exceptions apply (see [ohioabar.org/membershipplanpolicies](http://ohioabar.org/membershipplanpolicies) for more details). The OnDemand CLE Pass available for purchase applies only to self-study courses and expires on Dec. 31 of the membership year. All self-study courses reserved using the OnDemand CLE Pass must be completed in the year in which they are selected, as courses expire on the last day of the calendar year in which they were approved by the Supreme Court of Ohio.
